The City reserves the right to reject all bids or accept any bid, which in its sole and absolute judgment, shall under all circumstances, best serve the City's interests.

Bid Guarantee required pursuant to Wyoming State Statute §15-1-113(f). The City may require up to forty five (45) days after the opening of the bids for acceptance of the winning bid.

Pursuant to W.S. §16-6-106 preference is hereby given to materials, supplies, agricultural products, equipment machinery and provisions produced, manufactured, supplied or grown in Wyoming, quality being equal to articles offered by the competitors outside of the state.
